## Voting Rights Act Amendment of 2014

[LWWUS](#) is urging members to let their legislators know they support the Voting Rights Act Amendment of 2014, a recently proposed update to the 1965 Voting Rights Act that fixes the damage done to it by last year's Supreme Court decision that struck down the law's most powerful provision. The original law required states that had a history of voting rights violations to obtain preclearance from the federal government before enacting any new voting laws. The court felt that, while the basic principal of preclearance was acceptable, the formula for deciding which states needed preclearance was out of date.

In response to this, the VRA Amendment will create a new formula for determining which states will be subject to preclearance that takes into account current conditions, requiring states that have five or more violations of federal election law over the most recent 15 years to be listed for preclearance. The Amendment also allows for states to be added to the list if the federal government can show intentional voting discrimination. The law also includes new requirements for notifications of changes in state election laws, makes it easier to obtain injunctions against new voting laws, and expands the attorney general's power to monitor elections.

## Rail and Trail Plans for Santa Cruz County

Dondero will update us on plans for the Santa Cruz Branch rail line, including seasonal passenger service and freight service, as well as a future feasibility study for commuter and intercity passenger rail service. Caletti will present plans for a multi-use bicycle/pedestrian path (the rail/trail spine of a larger Monterey Bay Sanctuary Scenic Trail Network) and discuss the scope, goals, and development process for the Scenic Trail Network Master Plan.

Dondero's enthusiasm for sustainable transportation in all modes led him to join the Santa Cruz County Regional Transportation Commission in 2006 as Executive Director. Prior to arriving in Santa Cruz, he served as Executive Director at the Calaveras Council of Governments, and as a Project Manager at the Metropolitan Transportation Commission in the Bay Area.

After earning her Masters in Urban and Regional Planning, Caletti has spent the past 15 years at RTC working to create environments that incentivize getting around by foot or bicycle, believing that active transportation creates vibrant, healthy communities.
