LWVSCC proudly presents California Secretary for Natural Resources, the Honorable John Laird as the keynote speaker at our 50th Anniversary Celebration on February 22. Laird, who received his current appointment by Governor Jerry Brown in 2011, will inform us about some of the pressing issues concerning water in California as well as other priorities under his administration.

After graduating with honors in politics from University of California, Santa Cruz in 1972, Laird served on the staff of U.S. Representative Jerome Waldie, then as budget analyst for the Santa Cruz County Administrator. Laird spent nine years on the Santa Cruz City Council, including two terms as mayor. His service also includes work on the boards of many local and regional agencies as well as serving as the executive director of the Santa Cruz AIDS Project. Elected to represent the 27th district in the California Assembly in 2002, he served the maximum three terms, authoring 82 bills that were signed into law. Laird's career in public service spans 40 years, 23 of them as an elected official.

In his current position, Laird's top priorities include climate change adaptation, water conservation and supply reliability, enhanced relationships with tribal governments, State Parks access, farmland conservation, and oceans sustainability.

For the last year water issues at the state level have been in the forefront: the driest three years in recorded state history, a new state water action plan, a huge drought package, the first state groundwater monitoring law, and a bipartisan water bond that passed with two thirds of the vote. Resources Secretary John Laird will lay it all out in his February 22 talk.

Mike looks forward to assisting the League on environmental and conservation issues, especially those involving coasts and oceans.

Higher Education Study Committee

With our local program planning coming up in March (see calendar for details), we will be deciding the focus for our League's local programs for the 2015/16 year. At that meeting we will decide if LWVSCC will participate in the League's statewide Higher Education Study. Before our League can make that decision, we need to have an interested group of members willing to work on the committee for the study.

In order to support proposing the study as a topic for local program planning, we need a chair for the committee and a few members willing to work on it by mid-February. This spring, our local committee would begin to evaluate articles on the topic from the state committee to prepare for receiving the study guide in August 2015. The committee will also play a key role in educating our local League members and holding consensus meetings in March of 2016.

The study will examine access to quality public higher education in California, including funding, affordability, preparedness, equity, and opportunities and barriers to success. Public Higher Education in California is at a crossroads. Almost daily, news articles discuss public higher education and the need for reform. Unfortunately, because LWVC does not have a position on public higher education in California that includes the CSU and UC systems, the League cannot comment on or advocate for or against any legislation. This study was proposed and approved in order to remedy this situation and in recognition of the fact that education is the bedrock upon which democracy is built and sustained.

Water: Always an Issue in California

The LWVC Water Committee monitors current issues and recommends LWVC action concerning this essential, but controversial, element of life and politics in our state. The League remained neutral on Proposition 1, the water bond on the November ballot. Although we could enthusiastically support many of the projects funded by the measure, we had serious concerns about provisions emphasizing additional surface storage of water and the continuous appropriation of funds to the California Water Commission (CWC) for allocation to storage projects. With the passage of Prop 1, the LWVC has submitted recommendations to the CWC as it considers how to evaluate the public benefits of water storage proposals.
