## **Santa Cruz City Climate Action Plan Explained**

The City of Santa Cruz, a long-time advocate for environmental conservation and sustainable living, established its commitment to respond to global climate change by adopting the Santa Cruz Climate Action Declaration. Released this fall, the Draft Climate Action Plan outlines actions the City and the public can take to meet requirements and goals to reduce Green House Gas emissions. Ross Clark, Climate Action Coordinator for the City, will share his expertise on the development of the Plan and tell us what to expect in the future.

# President's Report

On September 14, I presented a League statement to the Santa Cruz City Council regarding an item on its agenda that would authorize a \$4 million contract with an engineering firm to design a desalination facility. The City of Santa Cruz is the lead agency for this proposed project which is intended to provide a new water supply for the Soquel Creek Water District, which presumably would enable the underlying overdrafted aquifers to recover. Santa Cruz City would use the desalinated water during a severe drought.

Although the League has not yet taken a position on the proposed desalination project, the League urged the Council to step back and rather than plunge into this very expensive project, commit to giving full consideration to the proposed alternatives being advocated by individuals and organizations in the community. These alternatives include, but are not limited to: modifying the management of water stored in Loch Lomond Reservoir, additional conservation measures, conjunctive use of existing surface and groundwater resources between water districts, and adopting a water-neutral development policy.

The public testimony presented by groups and individuals at the meeting and by email had a significant impact. Even though the Council voted to proceed with the award of a design contract, City staff was directed to develop a Plan B alternative to desalination and to come back for further evaluation and direction when the first phase of the desalination design has been completed. Staff had indicated that the first phase of the design was necessary in order to complete a draft environmental impact report (EIR), but also assured the Council that the design work could be stopped at that point if the Council wishes.

The desalination project is developing into one of the biggest controversies in the county's history. It is possible that the issue will be put to a vote of the people in the future. It is already an issue for the City Council candidates in the November election.
