For the first time in more than 20 years, the City of Capitola will be updating its General Plan which will address the key issues of enhancement of the 41st and Bay Avenue commercial corridors, parking and hotel development in the Village, promoting environmental and economic sustainability and preparation of a Climate Action Plan.

Throughout the process, the City will host meetings and workshops to obtain public input. The first public workshop is planned for March, 2011.
