What changes will the Patient Protection and Affordable Care Act bring to your life? How will it affect health care in Santa Cruz County? Join the League at our September luncheon for an update on this important legislation presented by Giang Nguyen, director of the County Health Services Agency.

News Briefs

✓ A provision of the Affordable Care Act has now come into effect that **requires insurance policies beginning after August 1, 2012 to fully cover the cost of preventative health care for women.** This includes contraception and various counseling, screening, and support services, which will be covered with no co-pay or deductible. ✓ In May the Environmental Protection Agency issued **draft guidelines for the use of diesel fuel in hydraulic fracturing.** On August 3, US League President Elizabeth Mac Namara responded to those guidelines with a list of questions and concerns. ✓ On August 7, 2012 **the California Historical Society honored the League of Women Voters of California** for its groundbreaking work in California's electoral history. The CHS stewards the official records of the LWV of California and San Francisco from 1900 to present.

✓ We encourage you to urge your state Senators to vote for these **two bills supported by the state League:** Election Day Voter Registration (AB 1436 – Feuer) and the California DISCLOSE Act (AB 1684 – Brownley), both currently making their way through the legislature. Vote with the League on November 6

LWV of California has announced their positions on this year's ballot measures. When League members have studied a subject and reached agreement on a particular position, the League supports ballot measures that agree with that position.

This November, the League supports the following three measures. Proposition 30, the Schools and Local Public Protection Act, begins to move California toward financial stability and adequate funding for all the services we want from our government. The SAFE California Act, Proposition 34, replaces the death penalty in California with a sentence of life in prison without the possibility of parole; the LWV supports abolition of the death penalty. The League supports a "Yes" vote on Proposition 40, the Referendum on Redistricting, because it retains maps drawn by the Citizens Redistricting Commission, a process supported by the LWV.

The League recommends a "No" vote on two measures. Proposition 31, the Government Performance and Accountability Act, creates a two-year state budget cycle, overhauls several aspects of the budgeting process, and makes changes to the legislative process. Although the measure is based on good intentions and has some pieces that, taken alone, the League could support, Prop 31 has several significant flaws and could result in years of legal challenges. The League also recommends a "No" vote on Proposition 32, the Special Exemptions Act, which the League feels is not the campaign finance reform measure its proponents say it is. Proposition 32 promises "political reform", but is really designed by special interests to help themselves and harm their opponents, and it does nothing to fix the problem of money in politics.

The League has taken a neutral position on two measures that they feel have some merit, but because they include provisions for the earmarking of funds, a practice the League does not support, they have not given them full support. Proposition 38, the Tax for Education and Early Childhood Programs, provides significant funding for education and early childhood programs and provides money to help the other underfunded government services. Proposition 39, Tax Treatment for Multistate Businesses, closes a tax loophole for multistate businesses, generating revenues of about \$1 billion per year—a good thing. However, it earmarks about half the new revenue for the first five years, so that portion can only be used for energy efficiency and alternative energy projects.

The League has not studied the issues addressed in the following measures, and so has no recommendation on Proposition 33 (Auto Insurance Rates), Proposition 35 (Human Trafficking), Proposition 36 (Three Strikes Reform), and Proposition 37 (Genetically Engineered Foods).
